The KCBS Professional BBQ Calcutta payoff will be based upon 50% of the total Calcutta pool. 50% of the Calcutta pool will be retained by The Smoke & Soul Fest to be applied to The Brain Injury Advocates of Wyoming (BIAW), and 50% of the total Calcutta pool will be paid out to the "owners" of the teams that place in the Calcutta. The KidsQ Calcutta payoff will be based upon 30% of the total Calcutta pool. 70% of the Calcutta pool will be retained by The Smoke & Soul Fest to be applied to The Brain Injury Advocates of Wyoming, and 30% of the total Calcutta pool will be paid out to the "owners" of the teams that place in the Calcutta.

- 2. Any person can bid on any team or teams and become the high, successful winning bidder for a particular team(s). REMEMBER, IF A COOKING TEAM DOES NOT BUY ITSELF DURING THE CALCUTTA, THE COOKING TEAM HAS THE RIGHT TO BUY BACK 50% FROM THE SUCCESSFUL PURCHASER. THIS MUST BE DECLARED AND PAID FOR PRIOR TO 9:00 AM SATURDAY, JULY 13, 2024 and settled with the purchaser, not the Smoke & Soul Fest or Brain Injury Advocates of Wyoming.
- 3. THIS YEAR CREDIT CARDS WILL BE ACCEPTED FOR CALCUTTA PURCHASES WITH A 3% PROCESSING FEE! CALCUTTA TEAM PURCHASES WILL HAVE TO BE PAID BY FRIDAY NIGHT.
 - 4. Up to three (3) places can be paid for the Overall Category. The Calcutta payout, which is 50% of the total Calcutta pool, will be distributed as follows:

All Individuals will need to have your ID with you the day of the Calcutta and the cook-off if you wish to purchase/drink alcohol. The Smoke & Soul Fest requests that no outside alcohol be brought with you on the premises and absolutely may not be handed out to the general public.
